
Focus topic: Environmental approvals update



Approvals update

Key points:


- There have been updates to key elements of the project that affect approvals in the first part of 2023.
- The environmental assessment of the project is being updated to take into account the updates to the project.
- We're working to finalise assessment on the updated project next year.




Approvals process

Key steps in the environmental assessment processes

A coordinated Environment Impact Statement (EIS) and Environment Effects Statement (EES) is being used to assess potentially significant environmental, social, economic and planning aspects of the project.






We'll go through a comprehensive environmental assessment process



Declared area and turbine design

- Declared area this reduced the area we've been investigating by around 12% and means all previous reports need to be updated.
- Maximum number of turbines we're assessing has reduced.
- Remodelling of impacts associated with turbines:
 - Collision Risk for birds.
 - Underwater noise.
 - Coastal processes.
 - Construction assumptions.



Gippsland offshore renewables zone January 2023


The Gippsland Offshore Wind Zone was declared in December 2022.



Working to minimise impacts

Refining the design including:

- Reduced turbine numbers
- Increasing blade tip clearance to a minimum of 35m to allow additional space for foraging birds.
- Assessment of noise mitigations for underwater piling – e.g. Double Bubble Curtains.



We're using the data from our studies to refine the project design.




Working to minimise impacts

Cultural heritage:

- Significant cultural heritage around waterways and in coastal areas.
- Exploring engineering and design responses such as:
 - Underground boring in key locations
 - Localised changes to transmission easement.

Native vegetation:

- Design refinement to avoid and minimise impacts.
- Looking at areas of higher significance and adjusting design and construction approaches.
